Subject: Grant of Recognition up to Elementary level under Right of Children to Free and Compulsory Education Act, 2009.

Sir/Madam,

With reference to your application dated 11-04-2013, I convey the grant of provisional recognition under Rule 14 of Delhi Right to Free and Compulsory Education Rules 2011 and amendment Rules 2013 to the Sanskriti Modern School, Plot No. 109, Strett NO.-8/3, Ratia Marg, SangamVihar, New Delhi-110062 (Name of the school with address) for Class Ist to Class VIIIth for a period of one years w.e.f. 01.04.2013 to 31.03.2014 or till the order to the contrary is passed by the appropriate authority, whichever is earlier, subject to condition that the School Management submit an undertaking that if any anomaly/irregularities regarding the land issue is detected in future the recognition will be cancelled.

The above provisional recognition is subject to fulfilment of following conditions:

The grant of provisional recognition does not in any way imply any 01. obligation for recognition beyond class V/VIII.

The School shall abide by the provisions of Right of Children to Free and 02. Compulsory Education Act, 2009 and the Delhi Right of Children to Free and Compulsory Education Rules, 2011.

The School shall admit in class I (or in entry class, as the case may be), to 03. the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion.

For the children referred to in paragraph 3, the School shall be reimbursed in accordance with the provisions of sub-section (2) of section 12 of the Act. To receive such reimbursements school shall maintain a separate bank account.

The Society/School shall not collect any capitation fee and subject the 05. child or his or her parent or guardian to any screening procedure.

The School shall not deny admission to any child for lack of age of proof shall adhere to the provisions of section 15 of the Act. The school shall ensure:

No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.

No child shall be subjected to physical punishment or mental (ii) harassment.

No child is required to pass any board examination till the (iii)

completion of elementary education.

Every child completing elementary education shall be awarded a certificate as laid down in under rule 22 of Delhi Right to Free and Compulsory Education Rules 2011.

The students with disabilities/special are given inclusive education

as per provision of the Act.

(vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years.

(vii) The teachers performs their duties as specified under section 24(1) of the Right to Free and compulsory Education Act 2009 and the

teachers shall not engage himself / herself for private coaching.

The School shall follow the syllabus on the basis of curriculum laid down by academic authority/ NCERT as the case may be

The School shall follow the three language formula for teaching from class 08.

That the Management of the school shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Manager of the school 09. and Dy. Director of Education (District concerned) equivalent to 3 months salary of staff or Rupees One Lac+Rs. 80/- per student within 3 months from the date of issue of letter.

The School shall submit building fitness certificate, NOC from chief Fire officer, water safety certificate from DJB and health certificate from local 10.

competent authority within six months of its date of application.

The School shall comply with the directions of the Hon'ble Supreme Court 11. of India regarding the arrangement made for transporting school students.

Salary to the staff shall be paid through crossed Cheque/Electronic 12.

clearance system.

The School shall maintain the standards and norms of the school as 13. specified in section 19 of the Right to Free and Compulsory Act 2009 and the instructions/orders issued from time to time. The facilities reported in application are as under:-

- 20. If the school is located in unauthorised /non-conforming area, it shall submit within six months of the date of application the following documents:
- Certificate from concerned authority of DDA that it has applied for (a) consideration with reference to zonal development plan and DDA is considering its application
- Certificate from SDM/ADM/Forest department that the applicant school is (b) not occupying Government land, Gram Sabha land and or protected Ridge
- The school shall not deny admission to any child for lack of age proof and 21. shall adhere to the provisions of section 15 of the RTE Act, 2009.
- The school shall abide by the directions issued by the Government from 22.
- The provisional recognition Code Number allotted to the school is Act-23. I/20132371. This may please be noted and quoted for any correspondence with the appropriate authority.
